Interested firms are required to submit their applications along with the following documents showing their credentials, expertise and financial strength:-

1. The words "Pre-qualification for each lot i.e. 1, 2, 3, and 4 shall be clearly written/marked on each sealed envelope.
2. Firm must have minimum of 2 years recent relevant experience for LOT # 1, 2 and 3 and minimum 5 years for LOT # 4. Company profile must clearly show year of establishment. (Documentary evidence should be attached)
3. Detail of capability/capacity with respect to personnel, equipment and plant.
4. Detail of Managerial capability.
5. Detail of nationwide network/ support offices for after sale service and spare parts.
6. Detail of similar types of works completed in Banks and other institutions during the last one year with documentary evidences.
7. Bank's technical team will visit Project sites and nationwide offices of shortlisted firms (if required).
8. Bank Certificate not over 6 months old confirming annual credit turnover of at least Rs. (.5) Million for LOT # 3 and (1.0) Million for LOT # 1,2 and 4.
9. Proof of Sales Tax Registration, NTN Certificate, and income tax deposited during last One (1) year.
10. Affidavit on stamp paper of Rs. 20/- signed by the authorized signatory of the firm to the effect that the firm is not black listed and is not a tax defaulter.
11. This ad is also uploaded on websites of PPRA ([www.ppra.punjab.gov.pk](http://www.ppra.punjab.gov.pk)) and BOP ([www.bop.com.pk](http://www.bop.com.pk)).
